- Hollywood: Financial summary (Promise Hollywood) was distributed (unaudited as of June 30, 2020)
 - o Net Cash as of August 24, 2020: \$719,743
 - o Unaudited Net Income as of June 30, 2020: \$256,665
 - o Per pupil slightly under
 - o Recorded CARES Act funding
 - o Expenses were under due to school shutdown.
 - Depreciation has not been adjusted and there may be additional CARES Act fund.
- Spring Hill: Financial summary (Promise Spring Hill) was distributed (unaudited as of June 30, 2020)
 - o Net Cash as of August 24, 2020: \$581,920
 - o Unaudited Net Income as of June 30, 2020: \$459,429

- o Finance committee is working on ways to maximize use of grants.
- o Tom: Both schools have full-time nurses and associated expenses are reflected in the budgets. CARES Act funding may cover some of the costs.

- Spring Hill: 2020-2021 Proposed Budget (Promise Spring Hill) was distributed and reviewed

 - Note: First 8 PreK –funding comes from First 8 but the program is managed by Porter-Leath. VPK 619 PreK is also managed by Porter-Leath
 - o Salaries are based on actual contracts in place.
