- Tennessee Public Charter School Commission almost done with the process of transitioning into the commission and renewing our charter application.
- Board on Track: Mandatory board member training
- Board Calendar board meeting and financial committee meeting calendars presented

Finance Report – Greg Thompson (GT3) and Stephanie Chittom

• Promise Academy Financial Update was distributed and discussed.

- o Hollywood 2022-2023 Year-End Financials:
 - Deficit (\$212,275)
 - We are still due approximately \$800,000 from the ASD (ASD submission window was delayed by 9 months)
- o Spring Hill 2022-2023 Year-End Financials:
 - Deficit (\$55,685).
- o Hollywood 2023-2024 Proposed Budget Review:
 - Surplus built in: \$56,835
 - Cash Flow: Hollywood has a line of credit of \$200K drawn down with Truist and \$100K with ManUp
- o Spring Hill 2023-2024 Proposed Budget Review:
 - Surplus built in: \$147,270
 - Cash Flow: Spring Hill has as line of credit of \$350K drawn down with Truist and \$100K with Man Up
- o This is the first year of TISA, the new funding formula: Avg. \$11,800/student; Some children are eligible for more funding but an average was used for budget purposes.
- We need to pay down \$750,000 in debt across both campuses
- Audit Stephanie Chittom
 - o PAHW should be done this week
 - o PASH should be completed in the next couple of weeks
 - o Our current firm is moving away from school audits so we will be sending out bids for new auditors.
- Man Up Loan

Motion: To approve and accept the loan agreement between Promise Academy and Man Up as presented. Motion seconded and approved.
