

Attendance Statistics

- All children, regardless of socio-economic background, do worse academically in 1st grade if they are chronically absent (missing 10 percent or more of school including excused and unexcused absences) in kindergarten.
- A recent study in California found that only 17
 percent of children chronically absent in both
 kindergarten and 1st grade were proficient
 readers by the end of 3rd grade as compared
 to 64 percent of their peers who attended
 regularly (missing less than 5 percent of school.)

Third Grade TCAP Retention Law


The following students are exempt from 3rd grade retention:











Fourth Grade TCAP Retention Law

4th Grade TCAP Adequate Growth

- Students promoted to the 4th grade through ELA tutoring must demonstrate adequate growth on the 4th grade ELA portion of the TCAP to be promoted to the 5th grade.
 - Based on district-reported data, this reflects approximately 12,000 students.
- The department's goal in proposing a definition of 4th grade TCAP adequate growth is to strike the best possible balance between precision and interpretability.
 - Use the most accurate and familiar metrics and methods as possible.

May 2024 Update: Schools and families will now meet to make the final determination based on a multitude of factors.



Transportation: Car Line

<u>Arrival</u>

- 7:30-8:00 am
- Use side of Bryan
 Street closest to
 the school
- Students will enter using the front door
- Watch for walkers

<u>Dismissal</u>

Transportation: Walker Door

<u>Arrival</u>

- 7:40-8:00 am
- Use the crosswalk
- Enter through the front door
- No student should enter from Merton St. (back gate)

Dismissal

- Use the crosswalk
- Students will be called by staff outside of SW 4
- Last student called-
 - > 3:13 (M-Th)
 - > 2:13 (F)

Transportation: School Bus

*Parents must pick up students from stop.

2 Routes

- Route 1: North Memphis/Frayser
- Route 2: North Mem/Raleigh



Eligibility

- All Students
- Parents complete paperwork
- Parent & Emergency contact
- Stop & Drop
- Parents must be present at the stop to pick up the child
- No parent at stop, student will be brought back to school
- Student Compliance

Title I/Federal Programs

- Receive Federal funding to support academic programs (Reading & Math intervention/Co-teachers)
- Teachers are licensed
- Rights to have proper notice
- School Accountability
- School Improvement Plan

Medication

- Over-the-Counter medicine is strictly prohibited. (cough drops, throat lozenges, aspirin, etc.)
- All prescription medications must be brought to the office.
- Student must have a medical authorization form completed by his/her Pediatrician authorizing medication at school.
- Only authorized personnel can dispense medication. (Nurse, Office personnel)

Medication: Asthma

- Student must have Asthma Form on file in the office.
- Must be kept under lock and key.
- Cannot carry medication on person without a notification of need from Pediatrician.
- Parent must complete Asthma Plan: provides in detail parent specifications for school personnel in the event student has attack. (take two breaths of inhaler twice, wait for 5 minutes before calling Parent)
- School Nurse will contact parents w/in the 1st month of school
- Need additional assistance? See Mrs. Hall
